Regular Meeting of the Lovells Township Board

May 14, 2019

PRESENT: Ann C. Duby, Cheryl Hopp, Cynthia Infante-Inman, Heather Lovell, and Gary A. Neumann.

Supervisor Neumann called the Board Meeting to order at 10:00 AM. Followed by the Pledge of Allegiance.

10:01 AM-Neumann moved, Lovell supported a motion to recess the Regular Meeting of the Board in order to convene a Public Hearing. All Ayes. MOTION CARRIED.

Neumann briefed on the purpose of the hearing: (1) receive public input regarding our application for a Michigan Natural Resources Trust Fund (MI NRTF) Grant to construct the proposed Lovells Access Site and (2) consider the adoption of a resolution of authorization to apply for the MI NRTF Grant and within the resolution outline total estimated cost of the proposed Public Access Site, plus the amounts of "in kind" and "cash" donations available to meet the local match requirement of the MI NRTF Grant program. Neumann briefed on the proposed Resolution in detail.

10:13 AM-Neumann opened Public Comment. Carol Brand asked for a copy of the project costs. Neumann stated he will provide after the meeting. Hopp asked, "When will the project start?" Neumann stated that, if the Grant is approved, construction may commence in the summer of 2020.

Neumann moved, Hopp supported a motion to accept the Resolution of Authorization to Apply for the Michigan Natural Resources Trust Fund Grant as presented. In a roll call vote: All Ayes. RESOLUTION ADOPTED.

Neumann moved, Hopp supported a motion to accept the minutes of the April 3, 2019 Special Meeting of the Board. All Ayes. MOTION CARREID.

Neumann moved, Lovell supported a motion to accept the minutes of the April 9, 2019 Regular Meeting of the Board as presented. All Ayes. MOTION CARRIED.

Neumann moved, Hopp supported a motion to approve pre-paid vouchers dated April 5, 2019 through May 9, 2019 as presented: General Fund totaling \$8,977.63; Direct Deposit Checks totaling \$6,750.67; Fire Fund totaling \$5,845.47; Landfill Fund totaling \$5,463.93, and Liquor Fund totaling \$88.97. In a roll call vote: All Ayes. MOTION CARRIED.

Assessing – Neumann reported that our Assessor will be working with Duby on Summer Tax Bills; Assessor finished her 20% review at Warblers Hideaway Association; She found construction at three parcels with no building permit; Neumann to address the permitting process in our Summer Newsletter.

Fire Department – Infante-Inman briefed on Chief Lewicki's written report; Five runs for the month of April (1-Fire/4-EMS); Dept. purchasing new wildland firefighting jump suits for personnel from Douglas

Safety for the cost of \$3,168.25 which was approved and funded by the Friends of the Lovells Fire & EMS.

Liquor Inspector- Infante-Inman reported received and on file.

Zoning Administrator – Infante-Inman briefed on Gauthier's written report- Two Zoning Permits issued and no Zoning matters to report for April 2019.
